

HOLDVEST Privacy Policy

This Privacy Policy is designed to assist you with understanding how www.HOLDVEST.com ('the Company' or 'company' or HOLDVEST, 'the Website', 'we', 'us' or 'our') collects, uses and shares the information you provide us when accessing or using the Website. What Information do we collect on the Website?

When you visit our Website, you may provide us with two types of information: personal information that you voluntarily disclose and that is collected on an individual basis, and information collected automatically when you use our Website or the services available on our Website ('Information').

Information we collect from you

Personal information is collected only when voluntarily offered and solely for purposes identified on our Website and in this document. Personal information means any information that is unique to you, including your **Name, Username, Password, E-mail address, Cryptocurrency addresses, and Physical address**.

By providing us with your personal information, you also consent for us to collect, hold, use and disclose your personal information in accordance with this Privacy Policy. In addition to providing the foregoing information, if you choose to correspond further with us through e-mail or through the contact section of our Website, we may retain, use and disclose the content of your messages together with your e-mail address and our responses.

Information you provide may also be provided to our partners to verify your compliance with any special conditions which might apply. This information is collected on the registration form for various reasons including:

- Your personal identification
- To enable us and our partners to contact you for customer service purposes
- To tailor the content of our site to meet the customer's needs
- To share certain information with selected partners
- To permit us or our partners to verify your compliance with any special conditions which might apply.

What Information is collected automatically?

When you use our Website or services available on our Website, we automatically collect information from your devices. This may include (but is not limited to) **Server Log Information** (login details, date and time of visits, pages viewed, IP address, time spent on our Website and the websites you visit just before and just after our Website); **Device Information** (information about the computer or mobile device you use to access our Website, including the hardware model, operating system and version, web browser and other device identifiers); and **Information Collected by Cookies and Other Tracking Technologies**.

Use of Information

HOLDVEST will use this information in the course of providing, maintaining, delivering or improving our services; understanding the online activity of our Website users; fulfilling relevant legal or regulatory requirements; providing users with the information or products/services

requested; answering inquiries or responding to communication; developing new products or services; sending users technical notices, support or administrative notifications; communicating news, products, services, events and other appropriate information; monitoring and analysing trends, usage and activities in connection with our Website; detecting, investigating and preventing fraudulent transactions or unauthorised/illegal activities; protecting the rights and property of relevant parties and stakeholders; linking, connecting or combining Information we collect from or about you with other Information; and carrying out any other purpose or reason for which the Information was collected.

Sharing of Information

Our partners are based worldwide and by agreeing to this Privacy Policy, you are consenting to the transfer of your personal data to these selected partners regardless of where they are based. By submitting your personal data, you agree to this transfer, storage or processing. We will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy.

Our website may occasionally contain links to and from the websites of our partner networks, advertisers and affiliates. If you follow a link to any of these websites, these websites have their own privacy policies and that we do not accept any responsibility or liability for these policies. We recommend that you check these policies before you submit any personal data to these websites. We do not sell or distribute your personal information to third parties for marketing purposes without your express consent. We will only share Information about you in the following ways:

- With your consent or at your instruction
- With our current or future parent companies, affiliates, subsidiaries and with other companies under common control or ownership with us or our offices internationally
- With third parties or service providers that perform work for us
- Certain information you may choose to share may be displayed publicly, such as your username and any content you post when you use interactive areas of our Website like our online forums
- In connection with a merger or sale of our company assets, or if we conduct a financing round or are involved in an acquisition or any other situation where Information may be disclosed or transferred as one of our business assets
- In response to a request for information if we believe disclosure is in accordance with, or required by, any applicable law, regulation or legal process
- If we believe your actions are inconsistent with our user agreements or policies, or to protect the rights, property and safety of any Website Party or others
- and with third parties where aggregate Information is disclosed which cannot be reasonably be used to identify you.

Session and data

Generic information about your computer's connection to the Internet called 'session data' will automatically be logged. This information is anonymous and cannot be used to track your personal information. Session data consists of your IP address, operating system and type of browser software being used and the activities conducted by the user while on our website. We collect session data because it helps us administer our website, track correlative information and to collate statistics in relation to visitor traffic. We may use your IP address to help us diagnose problems with our server.

Any personal data that you provide us with such as your name and address is neither gathered, nor stored in the cookies placed by our website and, as a result, your information will not be passed on to any third parties. The Website supports your right to block any unwanted Internet activity,

especially that of unscrupulous websites, but if you choose to block our cookies, this may disable certain features on our site.

Protection of Personal Information
